LIVE ANIMAL TRAPS:

ALTHOUGH OUR ANIMAL CONTROL OFFICERS ARE TRAINED IN THE VARIOUS WAYS AVAILABLE TO CAPTURE ANIMALS, MANY TIMES IT IS PHYSICALLY IMPOSSIBLE TO CATCH SOME OF THEM. DUE TO THE LIMITED STAFF AND THE GREAT NUMBER OF CALLS, WHICH MUST BE ANSWERED, ANIMAL CONTROL IS NOT ABLE TO STAY IN ONE LOCATION AND WATCH FOR AN ANIMAL, WHICH NEEDS TO BE CAPTURED. THEREFORE, ANIMAL CONTROL MUST RESORT TO LIVE ANIMAL TRAPS TO SOLVE CERTAIN KINDS OF NEIGHBORHOOD PROBLEMS.

DEKALB ANIMAL CONTROL USES A TRAP SIMILAR TO THE FAMOUS "HAVE-A-HEART" TRAP. LIKE THE OLD-FASHIONED RABBIT BOX, THESE WIRE CAGES ARE BAITED AND WHEN THE ANIMAL ENTERS TO GET THE FOOD, A DOOR CLOSSES BEHIND IT, PREVENTING ITS ESCAPE. THIS TRAP DOES NOT HURT THE ANIMAL! IT MERELY HOLDS THE ANIMAL INSIDE UNTIL THE ANIMAL CONTROL OFFICER CAN ARRIVE AND REMOVE IT. NO ANIMAL HAS EVER BEEN INJURED BY ONE OF ANIMAL CONTROL'S TRAP. THESE TRAPS MAY BE USED TO REMOVE BOTH DIFFICULT TO CAPTURE DOMESTIC ANIMALS AS WELL AS NUISANCE WILDLIFE. (AWARE SHOULD BE CALLED FIRST FOR ALL WILDLIFE AT 678-418-1111) BY USING THESE TRAPS, ANIMAL CONTROL IS BETTER ABLE TO SERVE YOU AND THE COMMUNITY BY UTILIZING OUR SMALL STAFF TO ITS FULLEST.

ALTHOUGH YOU MAY REQUEST A TRAP WITH A SPECIFIC ANIMAL IN MIND, THE OFFICER WILL REMOVE ANY ANIMAL CAUGHT IN THE TRAP. THE OFFICER WILL SET AND BAIT THE TRAP AND ALL YOU HAVE TO DO IS WATCH IT AND CONTACT ANIMAL CONTROL WHEN AN ANIMAL IS CAPTURED.

IF YOU REQUEST A TRAP TO BE PLACED ON YOUR PROPERTY, THERE IS A **TWENTY-DOLLAR (20.00) REFUNDABLE FEE**. THIS FEE HELPS TO DEFRAY THE COST OF REPLACING TRAPS, WHICH ARE WORN OUT THROUGH CONSTANT USE, INTENTIONALLY DAMAGED OR DESTROYED THROUGH MALICIOUS MISCHIEF.

IF THE TRAP IS LOST, STOLEN OR DAMAGED WHILE ON YOUR PROPERTY, BY SIGNING THIS FORM YOU WILL BE RESPONSIBLE FOR THE REPLACEMENT FEE FOR THE TRAP.
